# Build an Elvis Presley (EP) Fan Club on the blockchain

The problem we are trying to solve:

- 1. No single voice | EP Fan clubs are fragmented and unable easily to come together or pool resources for shared goals.
- 2. Fans have limited influence | Typical membership & content structures mean fans can end up paying recurring fees without the decision-making influence.
- 3. Limited access | A complex, opaque system of IP rights exists, centralized to rights holders, restricts access to EP content.
- 4. Restricted by location | A lot of authenticated EP memorabilia exists in private collections, limited to physical exhibitions by location, unable to be shared with the fans at scale.
- 5. No future roadmap | There's no common vision and plan for the future legacy of EP's digital estate that includes EP fans, beyond a few vested individuals & centralized organizations.









### **Our Vision**

We believe in a world where EP fans own and govern the future of Elvis' digital estate

- 1. One unified voice | We provide the tools for fans to become key decision makers in the future of Elvis' digital estate.












# The Elvis Presley Digital Estate Preserving the legacy




## How our project funds will be allocated









We have carefully planned how revenue raised from offering memberships will be allocated in a manner that balances long-term success with ongoing value for members. In simple terms, there are two parts to this:

#### The costs of delivering this project

Teams from all over the world have come together in service of this project and Elvis' legacy. Their costs have been factored into the budgeting as outlined in the chart on the right.

The community wallet represents 10% of the total funds raised. The intention is that these funds will be used for things like running community events and procuring rights to never before seen content and memorabilia. Specific decisions on how funds are directed will be made by Founding Members.

## The How?

The next section goes into more technical detail

It requires a base level of blockchain, NFT & metaverse understanding.

If you're new-to-NFTs, we got you. Hold onto your Blue Suede Shoes, we'll be sharing some educational content so this section all becomes clear.

## This is a Fully On-Chain NFT

The Elvis Legacy Council Token is stored completely on the blockchain and does not rely on external servers such as the IPFS for hosting media data. It is constructed entirely from code, with no pixel data whatsoever. The token is displayed using SVG (Scaled Vector Graphic) code that has been meticulously crafted to achieve it's inspired design, all within the constraints of storing such code entirely on-chain.

On-chain NFTs inscribe artwork directly on the blockchain, unlike other NFTs that use external servers to host images or videos, the brilliance lies in its immutability and permanence.









# Powered by the ERC721B, an even smarter smart contract

#### **ERC721**

Widely considered the gold standard for smart contract development and the backbone of many blue-chip NFT collections, the OpenZeppelin ERC721 is both feature-rich and reliable. However, with more projects and a growing user base a key weakness has emerged, high gas transaction costs for both minting and transferring NFTs.

#### ERC721A

Popularised by the Azuki project and dubbed the ERC271A, an implementation of the ERC721, it was able to achieve significant gas savings by minting multiple NFTs in a single transaction. An innovation in many respects, one sacrifice made for gas efficiency has been a reduced feature set, one example is the inability to mint random IDs, only sequential.

#### ERC721B

The ERC721B standard improves upon the ERC721A implementation by supporting a full feature set and utilising bitwise operations, whereby processing is performed on a binary level which is the most efficient way to process numbers. ### Key Definitions

Blockchain - a data structure that holds transactional records and while ensuring security, transparency, and decentralization. You can also think of it as a chain or records stored in the forms of blocks which are controlled by no single authority.

Community Wallet - Refers to the portion of the funds raised by this project that will be reserved for procuring real world Elvis memorabilia.

Decentraland - An Ethereum-based blockchain platform where users can purchase, build and monetize virtual reality applications.

DAO - A decentralized autonomous organization (DAO), is an organization represented by rules encoded as a computer program that is transparent, controlled by the organization members and not influenced by a central authority.

Ethereum - Ethereum is open access to digital money and data-friendly services for everyone — no matter your background or location. It's a community-built technology behind the cryptocurrency ether (ETH) and thousands of applications you can use today.

Gas Fees - Ethereum transaction fees, known as Gas Fees. When you mint your token you will incur a gas fee. These are payments made by users to compensate for the computing energy required to process and validate and vary depending the demand on the blockchain at that moment in time.

NFT - A non-fungible token is a unit of data stored on a digital ledger, called a blockchain, that certifies a digital asset to be unique and therefore not interchangeable. NFTs can be used to represent items such as photos, videos, audio, and other types of digital files.

Metamask - A cryptocurrency wallet used to interact with the Ethereum blockchain. It allows users to access their Ethereum wallet through a browser extension or mobile app, which can then be used to interact with decentralized applications. This is where your NFTs and Ethereum can be stored.

Minting - Is the process of creating tokens on the Ethereum blockchain.

Web3 - A new iteration of the internet that is based on the blockchain and incorporates concepts including decentralization and token-based economics.
